talented and are like any other foster youth. They are usually over 12 years old with little family available to care for them.

There are several types of probation youth can be on. Detailed information about each can be found on our website and in the Welfare and Institutions Code. Here is a brief summary of each:

Informal: This is where the minor and parent enter into a contract with Probation for supervision for a short period of time in an attempt to keep

the child from entering further into the system.

Formal: Court ordered probation for a period of six months. There are terms and conditions the child must follow during that time. If the child successfully completes, their record is sealed.

Ward of the Court: Court ordered probation until the person turns 21 years old.

There are terms and conditions that must be followed. If the minor does not follow the terms, they can be placed in Juvenile Hall or in foster care. Once the person has followed their terms and conditions for an extended period of time, they can be terminated from probation successfully and have their record sealed.
